CEMETERY DISTRICTS

Public Cemetery Districts are single-purpose special districts appointed by the County Board of Supervisors and formed and governed under the California Health and Safety Code. Under California Health and Safety Code Sections 8890-9225 Cemetery Districts are legally authorized to provide standard cemetery functions, including land acquisition, cemetery maintenance, and grounds-keeping. The Districts also conduct activities attendant to burials and disinterment's. In private religious and fraternal cemeteries, the costs of these services are reflected entirely in the prices of grave spaces, burial fees, and charges against endowment funds. Public Cemetery Districts finance these services through property taxes, the sale of burial plots, charges for openings and removals, and setting or markers.
